**TERMS & BILLING**

By signing this contract you are reserving a space in the Aftercare Program for the child(ren) listed on the first page of this contract. Please return this form to the Admissions office as soon as possible.

The cost of aftercare for the school year is divided into nine payments. Billing begins September 16th with your first payment due October 1st. The ninth and final installment is due June 1st. A sibling discount of 5% applies to each child's fees when two siblings attend aftercare; a 7% per child discount applies for three or more siblings (**please note there is no sibling discount with the Every Day, All Year Aftercare**).

***This contract represents a commitment to aftercare for the full school year.*** Any changes to an A La Carte aftercare schedule must be submitted before the 1st of the month in order to take effect that month; no changes are accepted after April 1st; and changes are applied and billed per calendar month only (no mid-month adjustments). If you wish to change from Every Day, All Year aftercare, the full year will be converted into the \$7.50 hourly A La Carte rate. Fee adjustments are not made for days not attended (i.e. medical appointments, snow days, vacations, sick days). School holidays and scheduled breaks are not charged and therefore not included in the calculation of our fees. All programs are contingent upon minimum enrollment; 30 days notice will be given if there are any changes in the program. Aftercare charges will be adjusted each time after 2 consecutive weeks of school closure due to COVID 19.

If families need care unexpectedly, aftercare is available on a limited basis without a contract if space permits:

- ***the same-day rate for aftercare is \$15.00 per hour per child, with billing in whole hour increments only.***
- ***the day-before rate for aftercare is \$10.00 per hour per child, with billing in whole hour increments only.*** (Parents must call 24 hours in advance to be billed at the day-before rate.)

**LATE PICK-UP FEE**

***A fee of \$25.00 is charged every quarter hour after 5:00 pm when a child is not picked up on time. This fee will be added to your bill if not paid directly to the on-site caregiver at pick up.***

In signing this contract, the parent/guardian acknowledges that they and their children have agreed to accept the rules and regulations established by the school currently and during the school year. The school has the right to suspend or dismiss any student as a result of his/her behavior. The undersigned acknowledges that they have read and understood the foregoing, and hereby agrees to terms and conditions stated in this contract.
